



Recommendation of Declaration of Dividends

The Board of Directors of Trafco Group B.S.C. resolved, at its meeting held on 26th February 2026, to recommend the distribution of dividend for the year ending 31 December 2025 to the shareholders whose names are registered on the company's register on the Record Date. This is subject to the approval of the company's shareholders on the upcoming Annual General Meeting and the Regulatory Authorities. The proposed distribution is as follow:

- a) **Cash Dividend:** 15% of share nominal value, equivalent to BD 0.015 per share amounting to BD 1,112,844 (Excluding Treasury Shares).
